# STATEMENT OF COOPERATION

It is understood that my child's attendance is a privilege and not a right and if at any time his/her conduct, academic progress, or cooperation with the school's policies and procedures, Verde Christian Academy reserves the right to terminate my child's enrollment.

# **STATEMENT OF FAITH**

- 1. We believe the Bible is the inspired, infallible and authoritative Word of God
- 2. We believe in one God, eternally existent in three persons: Father, Son, and Holy Spirit.
- 3. We believe in: the deity of the Lord Jesus Christ, His virgin birth, His sinless life, His ascension into heaven to sit at the right hand of the Father, and His personal and visible return in power and glory.
- 4. We believe the salvation is entirely by the grace of God through faith in the substitutionary death and resurrection of Jesus Christ, His Son.
- 5. We believe that regeneration by the Holy Spirit is necessary for the salvation of lost and sinful men.
- 6. We believe in the present ministry of the Holy Spirit by whose grace and indwelling the Christian is enabled to live a Godly life.
- 7. We believe in Heaven and Hell; that Heaven is a place of eternal life and bliss with our Savior, the Lord Jesus Christ, and that Hell is a place of eternal death and separation from God for those who have rejected His Son
- 8. We believe that marriage is an institution designed by God for one man and one woman. We believe that all sexual activity occurs only within this design.

# VCA CULTURAL STATEMENT

The mission of Verde Christian Academy (VCA) is to "educate students to know Christ personally, to excel academically, and to transform communities for God's glory." As part of our mission, our school also serves as an outreach ("missional school"), not just to Christian families but also to families who may have views different from what we believe and teach.

In current American culture, there are several "hot topic" social issues that are highly volatile. We need to clearly articulate what we believe and what we teach at Verde Christian Academy regarding the following topics. Our popular cultural views are often contrary to the values we hold at VCA. Our school bases its beliefs in the Bible, which we believe to be God's authoritative revelation. In this document, a Biblical perspective will be presented to clearly state what we believe and what we teach in these areas.

For any discussion of how Christians ought to engage in our culture, we emphasize that we must "lead with love." By this, we mean that in addition to any specific teaching we receive from the Bible on a topic, we must prioritize God's commands to "love the Lord our God with all our heart, with all our soul, with all our mind, and with all our strength," and to "love our neighbor as we love ourselves" (Mark 12:31-32). In this effort, where the popular view is not a Biblical view, we should always "speak the truth in love" (Ephesians 4:15).

### What is a Christian view of marriage?

We believe that God created marriage to be a life-long commitment between one man and one woman, and that sexual expression should only be between a husband and wife.

### What is a Christian view of divorce?

We believe that because God's intention was for life-long marriages, divorce is contrary to His will and should be avoided.

## What is a Christian view of gender identity and transgenderism?

The Bible clearly defines humans as either male or female (Genesis 1:26-28). There is no distinction between the gender of a person and the sex of the person- they are defined as either male or female.

## What is a Christian view of homosexuality or "same-sex attraction?"

The Bible not only confirms that sexual expression is only to be expressed between a male and female in the marriage union, it also clearly condemns homosexual sexual expression, which is clearly depicted as sin.


